That Article III, Chapter 149-22.1: Commercial vehicle parking restriction be and is hereby amended to read as follows: 36 37 38 § 149-22.1 **Commercial Equipment parking restrictions.** 39 40 A. No person shall park any commercial equipment or other tractor, trailer, or tractor trailer combination, upon any public or residential property, except for 41 the purpose of making local deliveries to said property. 42

44	B. No Person shall park any commercial equipment or other tractor, trailer or
45	tractor-trailer combination, having a gross weight in excess of 1 $\frac{1}{2}$ tons, upon
46	any commercial property unless the vehicle is registered in the name of the
47	property owner and used in the identified business of the property owner.

49	C. A violation of any provision of said article shall be cited as a municipal
50	infraction, subject to a fine of \$200 payable to the municipality by the person
51	charged in the citation within 20 calendar days of the summons.

53	BE IT FURTHER RESOLVED AND ORDAINED by the City Council of Glenarden,
54	Maryland that this Ordinance is and shall become effective twenty days following approval
55	by the Mayor or passage by the Council over the Mayor's veto.
