That Article III, Chapter 149-22.1: Commercial vehicle parking restriction be and 36 is hereby amended to read as follows: 37 38 § 149-22.1 Commercial Equipment parking restrictions. 39 40 A. No person shall park any commercial equipment or other tractor, trailer, or tractor 41 trailer combination, upon any public or residential property, except for the purpose of making local deliveries to said property. 42 43

45	trailer combination, having a gross weight in excess of 1 ½ tons, upon any

49	C. A violation of any provision of said article shall be cited as a municipal infraction,
50	subject to affine of \$200 payable to the municipality by the person charged in the
