**An Ordinance to Amend §149-22.1 Commercial vehicle parking restrictions**

**WHEREAS**, the City of Glenarden is a municipal corporation of the State of Maryland, and operating under Article XI-E of the Constitution of Maryland and §5-202 of the Annotated Code of Maryland as amended; and

**WHEREAS**, Article VII §149-14 provides entitled Parking Regulations providing for restriction on parking commercial vehicles upon residential property; and

**WHEREAS**, the City of Glenarden Codes, Chapter 149 (Vehicle and Traffic) is intended to give provisions that are in addition and supplementary to the provisions of Maryland Vehicle Law Titles 11 through 27 of the Transportation Article of the Annotated Code of Maryland, as amended, and in accordance with the authority specifically granted by such law; and

**WHEREAS**, under General Provisions of Chapter 149, § 149-4, Violations and Penalties, the Glenarden Code states “violation of any provision of this chapter or any supplement thereto shall be deemed a municipal infraction and shall be punishable as provided in § 1-20B of this Code.”

**NOW, THEREFORE, BE IT ORDAINED**, by the City Council of Glenarden, Maryland sitting in **Regular Session this 21st day of November, 2022** that:

1. That Article III, Chapter 149-22.1: Commercial vehicle parking restriction be and is hereby amended to read as follows:

**§ 149-22.1 Commercial Equipment parking restrictions.**

- A. No person shall park any commercial equipment or other tractor, trailer, or tractor trailer combination, upon any public or residential property, except for the purpose of making local deliveries to said property.

44 B. No Person shall park any commercial equipment or other tractor, trailer or tractor-  
45 trailer combination, having a gross weight in excess of 1 ½ tons, upon any  
46 commercial property unless the vehicle is registered in the name of the property  
47 owner and used in the identified business of the property owner.  
48

49 C. A violation of any provision of said article shall be cited as a municipal infraction,  
50 subject to a fine of \$200 payable to the municipality by the person charged in the  
51 citation within 20 calendar days of the summons.  
52

53 **BE IT FURTHER RESOLVED AND ORDAINED** by the City Council of Glenarden,  
54 Maryland that this Ordinance is and shall become effective twenty days following approval by  
55 the Mayor or passage by the Council over the Mayor’s veto.
