**Resolution To Appoint Roland Mincey to the Glenarden Youth Advisory Committee**

**Whereas**, by Resolution R-22-2010 (Nov. 9, 2009), the Council established the Glenarden Youth Advisory Committee, which is composed of five (5) members appointed by the Mayor and approved by the City Council; and

**Whereas**, the Youth Advisory Committee is a Public Body and must comply with the Maryland Open Meetings Act: and

**Whereas**, the Committee was established to develop and recommend a plan for the City to bring programs and services to City youth; and

**Whereas**, the Council wishes to approve the Mayor's appointment of Roland Mincey to the Youth Advisory Committee.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Glenarden, Maryland, sitting in **Regular Session this the 19<sup>th</sup> day September 2022** as follows:

1. The term of office shall be two (2) years **June 21, 2022 – June 23, 2024**.
2. Roland Mincey is hereby approved as an appointment to the Youth Advisory Committee.
3. This Resolution shall take effect immediately following approval by the Council and a favorable background check administered by the City of Glenarden.
4. That this Resolution shall take effect immediately upon adoption.
