- Mayor Cashenna A. Cross' Presentation of FY 2023 Budget Proposal
- Citizens Comments
  - > **Dr. Ky Gibbs** Is highly opposed to the tax increase.
  - ➤ Alonda McDuffie Mrs. McDuffie doesn't feel the Police Department and Code Enforcement job quality is adequate to request a tax increase.
  - ➤ Alonda McDuffie Mrs. McDuffie questions why the Gold Room isn't operating which can increase the revenue for the City of Glenarden.
  - ➤ Alonda McDuffie —The Citizen also wants the location of the beautification initiatives in the city.
  - ➤ Alonda McDuffie The sidewalks repairs need to be done as soon as possible, when can the citizens expect to see that work begin?
  - ➤ Alonda McDuffie What are the targeted locations as to where the speed bumps are being placed?
  - ➤ Paulette Brooks A tax increase would put unnecessary strain and financial burden on the seniors in the community.
  - C. Smallwood After giving the HR personnel a 3% increase will the HR person become full-time?
  - C. Smallwood How much money will be pulled from the savings account to balance the budget?
  - C. Smallwood What will happen to the programs after the ARPA funds have been depleted?
  - ➤ C. Smallwood Where are the charging stations going to be located?
  - C. Smallwood We need to put in the budget to replace the sandwich board that used to be located at corner of Fletcher and Church Street.
  - ➤ Mr. Spauyo WTC resident asks did the City take in consideration how all of the new property developments in the area could offset the revenue gaps in the budget to

- eliminate the need for tax increase?
- ➤ **Richard Arroyo-Montgomery** What is the actual increase, there is confusion between the two different tax notifications that was sent out to the residents? Is a constant yield rate of .3481 what you are proposing we be taxed on now...please provide clarification?
- Richard Arroyo-Montgomery The increase would cause an increase in the tune of \$1 per home, however, if we could maintain the lower rate to look out for our seniors that would be what is best.
- ➤ Atonn Muhammad The property tax increase is concerning as he is the son of an elderly Glenarden resident who is on a fixed income. Can we offset some of the burden of property taxes off on the local businesses?
- ➤ Anthony Foster Suggested doing a visual presentation explaining the tax adjustments going forward so the citizens can have a better understanding of how the decision will impact their day to day lives.
- ➤ Barbara Lucas Would like to go back to in person meetings.
- ➤ Barbara Lucas Please include McLean Ave and MLK Blvd on the listing for speed bumps and traffic cameras before someone gets hurt.
- ➤ Barbara Lucas Is Village in the Woods Apartments a part of the City of Glenarden? The citizen is concerned about code violations.
- Barbara Lucas Why isn't anyone doing anything with the Landover Mall lot property?
- ➤ Barbara Lucas Thank you for rebuilding the recreation center for the kids.
- ➤ Barbara Lucas Why are the Police officers driving the police vehicles home at night as it could be saving revenue leaving the cars at the municipal center.
- ➤ **G. Jerry Velazquez** It is hard to make heads or tails of the tax increase letters regarding understand the language and numbers. What is the true dollar impact to the average citizen of the City of Glenarden...it is hard to understand what you are trying to convey in the document?
- Mrs. Harrison Will the tax rate be on the ballot for the citizens to vote on in July?
- Sandra Jackson Regarding Speed bumps and speed cameras...traffic calming mitigation efforts need to be taken on Glenarden Pkwy.
- Vote to determine the FY 2023 Constant Yield Rate
